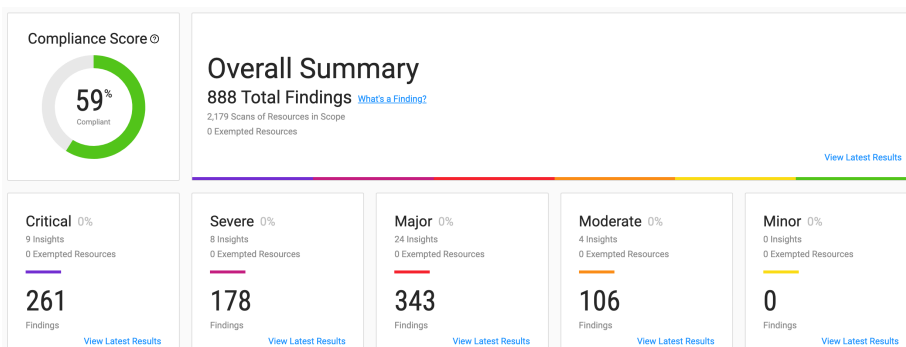


Figure 1. HPE Managed IT Compliance dashboard

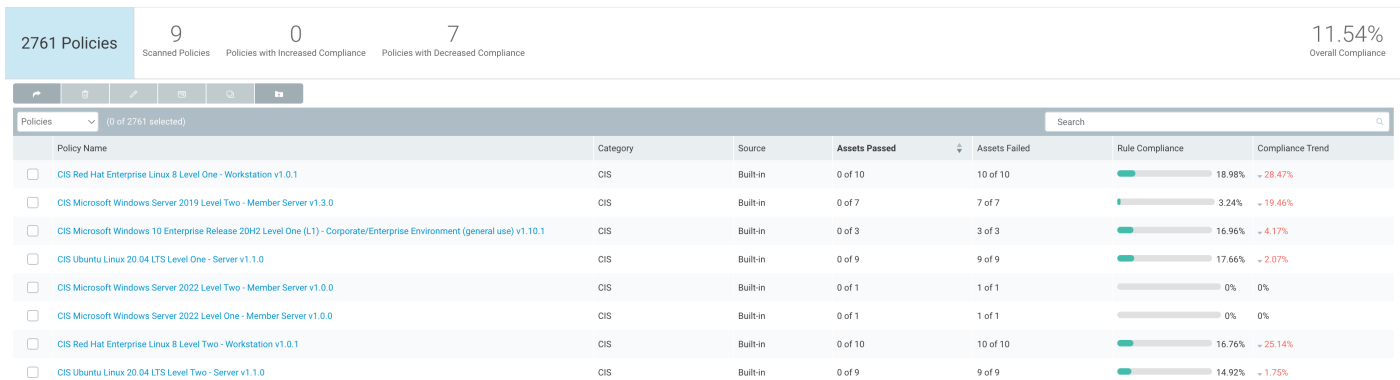


Figure 2. HPE Managed IT Compliance audit dashboard

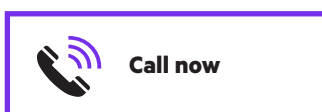
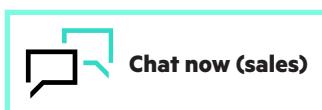
